A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CONSENTING TO A JOINT PUBLIC HEARING ON THE PROPOSED SIXTH AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE COLUMBIA REDEVELOPMENT PROJECT, AUTHORIZING THE ESTABLISHMENT OF A DATE, TIME AND PLACE THEREFOR, AND AUTHORIZING PUBLICATION AND MAILING OF NOTICE OF SUCH JOINT PUBLIC HEARING.

WHEREAS, the California California Community Redevelopment Law (California Health and Safety Code, Section 33000 et seq.) authorizes a joint public hearing on the proposed Sixth Amendment to the Redevelopment Plan for the Columbia Redevelopment Project (the "Project"), with the consent of the Redevelopment Agency of The City of San Diego (the "Agency") and the City Council of The City of San Diego (the "Council"); and


WHEREAS, the Agency by resolution has consented to a joint public hearing on the proposed Sixth Amendment to the Redevelopment Plan for said Project and has requested that the Council consent to such joint public hearing and establish the date, time and place therefor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Council hereby consents to a joint public hearing with the Agency on the proposed Sixth Amendment to the Redevelopment Plan for the Project and hereby authorizes the City Clerk, in cooperation with the Executive Director of the Agency, or her designee, to establish the date, time and place therefor.

2. The City of San Diego shall, by its designee and in cooperation with the Executive Director of the Agency, or her designee, publish and mail notice of public hearing on the proposed Sixth Amendment to the Redevelopment Plan, in the manner, and with other documents as required and established by law.
