APPROVING PARCEL MAP T.M. NO. 84-0326.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Victor Rodriguez-Fernandez, Licensed Land Surveyor, entitled "PARCEL MAP T.M. NO. 84-0326 being a division of a portion of Lot A-223, of Addition No. 5 to San Ysidro, according to Amended Map thereof No. 1405 filed in the office of the San Diego County Recorder on January 2, 1912 in The City of San Diego, County of San Diego, State of California, together with a portion of Averil Road, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Averil Road and South Vista Avenue, and said portions of public streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on the parcel map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council and that said Council has approved said parcel map, and that said portions of public streets are

accepted on behalf of the public as heretofore stated; all as granted and shown on this map within this division, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
