

City of San Diego, et. al. resulting from the personal injuries to Gregory Larson, Kevin Walsh and Lynn Barton.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue three checks; one check in the amount of \$53,000.00 made payable to Gregory Larson and Jeffrey P. Wade, his attorney, 2718 Fifth Avenue, San Diego, CA 92103; a second check in the amount of \$38,000.00 made payable to Kevin Walsh and Jeffrey P. Wade, his attorney; and, a third check

in the amount of \$17,000.00 made payable to Lynn Barton and Jeffrey P. Wade, her attorney., in full settlement of the lawsuit and of all claims.


