WHEREAS, Pacific Bell has continued its efforts in rate increase applications; and

WHEREAS, said original allocation and augmentation of funds have been expended in support of participation in said hearings

and it is now desired and necessary to augment again said resolution to continue participation by San Diego in this field of concern; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer the amount of \$5,000 within Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of providing funds to augment Resolution No. R-268164 for expenses incurred in connection with said participation in the above California Public Utilities Commission rate hearings relating to Pacific Bell.
