Elaine McGrath	Engineering & Development	\$393.00	Ms. McGrath is a Senior Clerk Typist. She suggested having the Special Assessment Bonds printed by the Print Shop, instead of an outside printer. Estimated savings are \$1,310 in printing charges. This is a partial award pending a 12-month review.
Robert Hauptman	General Services	\$258.15	Mr. Hauptman was a Refrigeration Mechanic with the Buildings Division at the time of this suggestion. He suggested changing the motors on the cooling tower for the City Operations Building serving the heat of the lighting system. Actual savings of \$520.80 in energy was realized. This is the remainder of his award.
Gabriel Sanchez-Aldana	General Services	\$180.00	Mr. Sanchez-Aldana was an Airport Operations Assistant at the time of this suggestion. He suggested the removal of a Taxi-Way sign at Brown Field. Actual savings of \$600 has been realized in materials. This is his full award.
