RESOLUTION NUMBER R- 272421

ADOPTED ON NOV 28 1988

WHEREAS, the people of the State of California have enacted the California Wildlife, Coastal and Park Land Conservation Act of 1988, which provides funds to the State of California and its political subdivisions for acquiring and/or developing facilities for public recreational and open space purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of applications before submission of said applications to the state; and

WHEREAS, said applications contain assurances that the applicant must comply with; and

WHEREAS, the applicant will enter into an agreement with the State of California for acquisition or development of the projects; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council approves and authorizes the filing of an application for the Per Capita Grant Program under the California Wildlife, Coastal, and Park Land Conservation Act of 1988 state

grant assistance, in accordance with the grant application and agreement on file in the office of the City Clerk as Document No. RR- 272421 .

2. That the applicant understands the assurances and certification in the application form.


3. That the Council certifies that said applicant has or will have sufficient funds to operate and maintain the projects.

4. That the City Manager, or his representative, be and he is hereby authorized to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned projects.

5. That the City Auditor and Comptroller is hereby authorized to establish a fund which will earn its own interest if the grant is funded.

6. That the City Manager and the City Auditor and Comptroller are hereby authorized to use and apply Proposition 70 Per Capita Grant funds to City-wide playground equipment and park improvement projects, in accordance with standard City procurement and construction procedures.
