BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the University of San Diego Law Center to develop a program in conjunction with the San Diego Law Center in which an Alternative Dispute Resolution Hearing Officer would be added to the City's Code Enforcement staff and in which an Environmental Court would be created to hear government-initiated criminal and civil actions in the area of municipal and land use law. The terms and conditions set forth in the Agreement are on file in the office of the City Clerk as Document No. RR- 272427.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$62,709 from The City of San Diego to San Diego Law Center.
