BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney be and he is hereby fully authorized to execute a letter retainer agreement with the law firm of McDermott, Will and Emery, pursuant to the terms and conditions of that letter, dated November 7, 1988, a copy of which is on file in the office of the City Clerk as Document No. RR-272431, to serve as outside counsel in connection with Lindbergh Field airport clear zone matters.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$25,000 from the Unallocated Reserve (605) to the Allocated Reserve (901) to provide funds for the above retainer agreement and expend said funds as requested.
