WHEREAS, City Manager's Report No. 87-564 presented the City Council with several recommendations concerning the formulation of a job development plan for San Ysidro; and

WHEREAS, on April 11, 1988, the City Council adopted several recommendations outlined in City Manager's Report No. 87-564 and, in addition, directed the City Manager to have further discussions with City staff, local businesses, the Private Industry Council/Regional Employment & Training Consortium, and the Foreign Trade Zone Operator to develop a cooperative program with community support; and



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to include provisions in the Foreign Trade Zone Operator Agreement, that would require the Operator to make known, in a timely manner, to

the Private Industry Council/Regional Employment & Training Consortium, the following: the company name, contact person, address and phone number of users committed to operating within the Foreign Trade Zone.
