
ADOPTED ON NOV 28 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council does not intend to apply any section or part thereof, including but not limited to Sections 6, 7, 9 and 11 of the Development Agreement between the City and Otay International Center adopted by Ordinance O-16749 (New Series) on November 10, 1986 and on file in the office of the City Clerk as Document No. OO-16749 to Parcel 1 of Parcel Map 15261 for so long as the United States of America retains its sovereign control of the Parcel and the Parcel is used solely for United States Government purposes directly associated with a Border Crossing facility.

BE IT FURTHER RESOLVED, that the City will not attempt to assess the property or include the property in any municipal improvement, utility, or maintenance district(s), as long as the property is in the ownership of the United States of America and used in its sovereign capacity.
