## RESOLUTION NUMBER R- 272450 ADOPTED ON NOV 2 9 1988

WHEREAS, there exists a need for stronger enforcement techniques under the San Diego Municipal Code which can be used to enforce a wide range of Municipal Code ordinances, including land development regulations; and

WHEREAS, stronger enforcement techniques are needed under the San Diego Municipal Code as to have a meaningful effect on violators and to serve as a strong disincentive against future violations; and

WHEREAS, the Transportation and Land Use Committee has approved a "Civil Penalties Ordinance" prepared by the City Attorney to effectuate this purpose; and

WHEREAS, the "Civil Penalties Ordinance" would allow for the assessment of significant civil penalties against violators through an administrative hearing process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager is hereby authorized and directed to develop a comprehensive program to implement the "Civil Penalties Ordinance."

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to establish an administrative hearing process for the imposition of civil penalties including guidelines for establishing the amount of civil penalties to be assessed.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to establish a fund for the deposit of all penalties collected and develop a cost effective program for the equitable disbursement of such monies, including reimbursement to the City departments for costs incurred.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to develop a centralized enforcement program to specially target serious Municipal Code violations including land use violations and which would effectively utilize stronger enforcement techniques such as the civil penalties ordinance.
