STIMSONITE, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of 2-PART PAVEMENT MARKER EPOXY, BITUMINOUS ADHESIVE AND REFLECTIVE RAISED PAVEMENT MARKERS as may be required for a period of one (1) year beginning December 1, 1988 through November 30, 1989, per prices on file in the Purchasing Department, as follows:

1. JOHN C. HENBERGER CO. INC. for Items 1 and 2, Epoxy and Bituminous Adhesive; terms net 30 days, plus sales tax, with an option to renew contract for three (3) additional one (1) year periods, price increase not to exceed 3% of original year prices.
2. STIMSONITE for Items 3, 4, 5 and 6, Reflective Raised Pavement Markers; terms 1% 20 days, plus sales tax, with options to renew contract for three (3) additional one (1) year periods, price increases not to exceed 3% of original year prices.
