BE IT RESOLVED, by the Council of the City of San Diego that all bids theretofore received on October 14, 1988, pursuant to publication of notice calling for bids on CONSTRUCTION OF SOUTHEAST ATHLETIC AREA - IMPROVEMENTS are hereby rejected.

BE IT FURTHER RESOLVED, that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF SOUTHEAST ATHLETIC AREA - IMPROVEMENTS filed in the office of the City Clerk of the City of San Diego, California, on DEC 12 1988, and bearing official Document No. W.O. 118922, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SOUTHEAST ATHLETIC AREA - IMPROVEMENTS in accordance with the specifications.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$20,713 (\$2,551 from PSD Fund 11660 and \$18,162 from PSD Fund 15000) to CIP No. 29-579 SOUTHEAST ATHLETIC AREA - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$20,713 from CIP No. 29-579 SOUTHEAST ATHLETIC AREA - IMPROVEMENTS to supplement funds previously authorized by Resolution No. 271868, adopted on September 19, 1988, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
