
RESOLUTION NUMBER R- 272495

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the California Department of Transportation (CALTRANS), for the design and construction of a traffic signal and safety lighting at the intersection of Genesee Avenue and the southbound off-ramp of State Route 163, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 272495 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$94,200 (50% of the total cost of the signal and safety lighting) from C.I.P. No. 68-001.1, "Cooperative Signal Projects," is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
