
RESOLUTION NUMBER R- 272501

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$16,000 from 1988-89 CDBG Fund 18524, Dept. 5666, Org. 6605, Job Order No. 006605, is hereby authorized solely and exclusively for the purpose of providing funds for the above project.
