

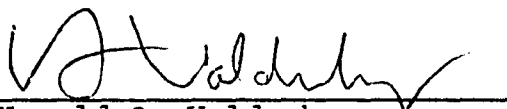

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with PACIFIC SOUTHWEST REALTY COMPANY for the lease of 3,265 square feet of office space in the Security Pacific Plaza, for a 60-month term beginning January 15, 1989, with a first year cost of \$68,565, for use by the Mayor's Office, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR-272505.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$45,926 from Nondepartmental Outside Office Space Rental Fund (061043) for lease costs from January 15, 1989, through June 30, 1989, (\$31,426) and for relocation costs (\$14,500), is hereby authorized and approved.
