RESOLUTION NUMBER R-272520

ADOPTED ON DEC 12 1988

WHEREAS, the City Council by Resolution No. R-268232 on April 27, 1987 created the "Metropolitan Treatment Facility Task Force," commonly referred to as the Metropolitan Sewer Task Force (MSTF); and

WHEREAS, nineteen (19) months of continuous and valuable operation, including an internal workshop to assess the structure and workings of the Task Force, have given rise to suggested modifications in the Task Force organization to improve its efficiency and responsiveness to its stated purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a Navy representative is hereby added to the composition of the Task Force, with said member to be designated by the U.S. Navy.

BE IT FURTHER RESOLVED that Mr. Granville (Bo) Bowman, County Public Works Officer, is hereby elevated from his current status as a resource member to a full voting member of the Task Force.

BE IT FURTHER RESOLVED that the previously established non-voting resource members are hereby eliminated from the Task Force.
