BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$40,000 from Buildings Division Job Order Account 51313, Fund 100, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
