BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF STEAM REPLACEMENT - COMMUNITY CONCOURSE/ CENTRAL LIBRARY filed in the office of the City Clerk of the City of San Diego, California, on DEC 12 1988, and bearing official Document No. W.O. 118868, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF STEAM REPLACEMENT - COMMUNITY CONCOURSE/CENTRAL LIBRARY in accordance with the specifications.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$105,000 from Capital Outlay Fund 302453, CIP No. 37-003 ANNUAL ALLOCATION - FACILITY REQUIREMENTS to CIP No. 37-416 STEAM SOURCE REPLACEMENT - COMMUNITY CONCOURSE/CENTRAL LIBRARY.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$105,000 from Capital Outlay Fund 302453, CIP No. 37-416 STEAM SOURCE REPLACEMENT - COMMUNITY CONCOURSE/CENTRAL LIBRARY to supplement funds previously authorized by Resolution No. 271468, adopted on July 25, 1988, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
