BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$5,350 from CDBG Fiscal Year 1989 Fund 18525, for audit of the CDC by the firm of Quezada Navarro & Company for the CDC year ending September 31, 1988 is hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$212,000 from CDBG Program Income Fund 18502 to CDBG Fiscal Year 1989 Fund 18525.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$194,530 from CDBG Fiscal Year 1989 Fund 18525, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the agreement with the Certified Development Corporation.
