
ADOPTED ON DEC 12 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with TORREY PINES HOTEL ASSOCIATES, for the construction of a Fire Department emergency access road at the Torrey Pines Golf Course, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-272558 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$34,489 from CIP No. 29-648, Torrey Pines Golf Course Requirements, Torrey Pines Improvement Fund No. 10530, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
