WHEREAS, the Planning Commission approved and recommended adoption by the City Council of the Rancho Bernardo Community Plan update; and

WHEREAS, the Rancho Bernardo Community Plan update would serve to preserve the existing scale and character of development in these areas and would assist in the implementation of the goals and objectives stated in the community plan; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider said update and, by a majority vote, approved said plans and rescinded the 1978 Rancho Bernardo Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the Rancho Bernardo Community Plan update, a copy of which is on file in the office of the City Clerk as Document No. RR- 272586, and rescinds the 1978 Rancho Bernardo Community Plan.

BE IT FURTHER RESOLVED, that the City Council hereby approves the following conditions:
