

RESOLUTION NUMBER R- 273934

ADOPTED ON JUL 10 1989

WHEREAS, the Legislature of the State of California has enacted the Roberti-Z'berg-Harris Urban Open Space and Recreation Program, which provides funds to certain political subdivisions of the State of California for acquiring lands and for developing facilities to meet urban recreation needs; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for administering the program, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require all applicants to certify by resolution the approval of applications prior to their submission to the State; and

WHEREAS, said applications contain a certification that the applicant will comply with all federal, state and local environmental, public health, relocation, affirmative action and clearinghouse requirements and all other appropriate codes, laws and regulations prior to the expenditure of the grant funds; and

WHEREAS, the project(s) applied for under this program must be of a high priority and satisfy the most urgent park and recreation needs, with emphasis on unmet needs in the most heavily populated areas; NOW, THEREFORE,

2. certifies that it understands the general provisions of the agreement;

3. certifies that it has or will have sufficient funds to operate and maintain the project(s) funded under this program;

4. certifies that it has or will have available, prior to commencement of any work on the project(s) included in this application, the required match;

5. certifies that the project(s) included in its application conform to the recreation element of any applicable city or council general plan;

6. appoints the Deputy City Manager as agent of The City of San Diego to conduct all negotiations and execute and submit all documents, including but not limited to applications, agreements, amendments, payment requests, etc., that may be necessary for the completion of the aforementioned project; and


7. appoints the City Attorney as its legal counsel with authorization to sign the certification of page 1 of the application.
