ADOPTED ON JAN 9 1989

AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 7, DIVISION 38, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 67.38 THROUGH 67.38.8 RELATING TO WATER CONSERVATION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 7, Division 38, of the San Diego Municipal Code be and the same is hereby amended by amending Sections 67.38 through 67.38.8, to read as follows:

# SEC. 67.38 EMERGENCY WATER REGULATIONS - DECLARATION OF EMERGENCY

SEC. 67.38.1 SCOPE.

No change.

#### SEC. 67.38.2 DECLARATION OF POLICY.

It is hereby declared that, because of the conditions prevailing in the City of San Diego, the general welfare requires that the City maximize the beneficial use of its available water resources to the extent to which they are capable, and that the waste or unreasonable use, or unreasonable method of use of water be prevented and the conservation of such water is to be extended with a view to the reasonable and beneficial use thereof in the interests of the people of the City of San Diego and for the public welfare.

## SEC. 67.38.3 AUTHORIZATION.

The City Manager, or his designate, upon the recommendation of the Director of the Water Utilities

Department, is hereby authorized and directed to implement the applicable provisions of this Chapter upon his determination that such implementation is necessary to protect the public welfare and safety under the following conditions:

- a. In the event of an unforeseeable disaster or water emergency such as an earthquake, aqueduct break, or other major disruption in the water supply, the City Manager, or his designate, is authorized to implement the emergency provisions of this Ordinance as provided herein. Public notice will follow enactment of said provision.
- b. In the event of a foreseeable emergency such as extended drought conditions, the City Manager or his designate, may be authorized to implement the applicable provisions of this Ordinance as provided herein, after holding a public hearing before the City Council.

### SEC. 67.38.4 APPLICATION.

#### SEC. 67.38.5 WATER CONSERVATION STAGES.

First paragraph - No change.

### (a) Stage 1. Normal Supply Level Available.

Stage 1 applies during periods when a normal supply and distribution capacity is available, while at

the same time demand levels are not expected to significantly increase in the immediate future. All elements of Stage 2 shall during Stage 1 apply on a voluntary basis only.

(b) Stage 2. Mandatory Compliance-Water Alert.

Upon implementation by the City Manager and publication of notice, the following restrictions shall apply to all persons.

Elements of Stage 2 include:

- (1) Irrigation utilizing individual sprinklers or sprinkler systems for lawns, gardens, landscaped areas, trees, shrubs or other plants is prohibited except on designated days and hours. Irrigation of lawns, gardens, landscaped areas, trees, shrubs or other plants is permitted at anytime if:
  - (a) a hand-held hose is used, or
  - (b) a hand-held, faucet filled bucket of five(5) gallons or less is used, or
  - (c) a drip irrigation system is used, or
  - (d) reclaimed wastewater is used.

EXCEPTION: Commercial nurseries, commercial sod farmers and similarly situated establishments are exempt from Stage 2 irrigation restrictions but will be requested to curtail all nonessential water use.

(2) The washing of automobiles, trucks, trailers, boats, airplanes and other types of mobile

equipment, unless wash water is recycled or reclaimed wastewater is used, is prohibited except during designated hours on designated irrigation days. Such washing, when allowed, shall be done with a hand-held bucket or a hand-held hose equipped with a positive shutoff nozzle for quick rinses. The nozzle shall be removed when the hose is not in use.

EXCEPTION: Washing may be done at any time on the immediate premises of a commercial car wash or commercial service station or with reclaimed wastewater. Further, such washings are exempted from these regulations where the health, safety and welfare of the public is contingent upon frequent vehicle cleanings, such as garbage trucks and vehicles to transport food and perishables.

- (3) The filling, refilling or adding of water to uncovered outdoor swimming pools, wading pools or spas is prohibited except during designated hours on designated irrigation days.
- (4) The use of water for irrigation of golf courses is prohibited except during designated hours on designated irrigation days; however, the irrigation of golf courses utilizing reclaimed wastewater is not subject to irrigation prohibitions.
- (5) Use of water from fire hydrants shall be limited to fire fighting, related activities or other activities necessary to maintain the health, safety and welfare of the citizens of San Diego.

- (6) All restaurants are prohibited from serving water to their customers except when specifically requested by the customers.
- (7) Water shall not be used to wash down sidewalks, driveways, parking areas, tennis courts, patios or other paved areas, except to alleviate immediate fire or sanitation hazards or unless done with reclaimed wastewater.
  - (c) Stage 3. Mandatory Compliance-Water Warning.

Upon implementation by the City Manager and publication of notice, the following restrictions shall apply to all persons.

Elements of Stage 3 include:

(1) All outdoor irrigation of vegetation shall occur only during designated hours on designated days and must utilize hand-held hoses, drip irrigation or hand-held buckets.

EXCEPTION: Permanently installed sprinkler systems may be used only during designated hours on designated days; however, irrigation using reclaimed wastewater is not subject to irrigation prohibitions.

(2) The washing of automobiles, trucks, trailers, boats, airplanes and other types of mobile equipment not occurring upon the immediate premises of commercial car washes or commercial service stations and not in the immediate interest of the public health, safety and welfare shall be prohibited, unless done with reclaimed wastewater or wash water is recycled.

- (3) The filling, refilling or adding of water to uncovered outdoor swimming pools, wading pools or spas is prohibited.
- (4) The watering of all golf course areas, except greens, is prohibited unless done with reclaimed wastewater. Irrigation of golf greens shall occur during designated hours, unless done with reclaimed wastewater.
- (5) Use of water from fire hydrants shall be limited to fire fighting or other activities immediately necessary to maintaining the health, safety and welfare of the citizens of San Diego.
- (6) All restaurants are prohibited from serving water to their customers except when specifically requested by the customers.
- (7) Water shall not be used to wash down sidewalks, driveways, parking areas, tennis courts, patios or other paved areas, except to alleviate immediate fire or sanitation hazards or unless done with reclaimed wastewater.
- (8) The operation of any ornamental fountain or similar structure is prohibited, unless done with reclaimed wastewater.
  - (d) Stage 4. Mandatory Compliance Water Emergency.

Upon implementation by the City Manager and publication of notice, the following restrictions shall apply to all persons.

Elements of Stage 4 include:

- (1) All outdoor irrigation of vegetation shall be allowed only during designated hours on designated days, unless done with reclaimed water.
- (2) Commercial nurseries, commercial sod farmers and similarly situated establishments shall water only on designated days during designated hours and shall use only hand-held buckets, hoses or drip irrigation unless done with reclaimed water.
- trailers, boats, airplanes and other types of mobile equipment not occurring upon the immediate premises of commercial car washes or commercial vehicle service stations and not in the immediate interest of the public health, safety and welfare shall be prohibited, unless done with reclaimed water or wash water is recycled.
- (4) The washing of automobiles, trucks, trailers, boats, airplanes or other types of mobile equipment upon the immediate premises of commercial car washes or commercial vehicle service stations in the immediate interest of the public health, safety and welfare, shall occur only during designated hours, unless done with reclaimed water.
- (5) The filling, refilling or adding of water to swimming pools, wading pools or spas is prohibited.
- (6) The watering of all golf course areas, except greens, is prohibited unless done with reclaimed

wastewater. Irrigation of golf greens shall occur only during designated hours, unless done with reclaimed wastewater.

- (7) Use of water from fire hydrants shall be limited to fire fighting or other activities immediately necessary to maintain the health, safety and welfare of the citizens of San Diego.
- (8) All restaurants are prohibited from serving water to their customers except when specifically requested by the customers.
- (9) Water shall not be used to wash down sidewalks, driveways, parking areas, tennis courts, patios or other paved areas, except to alleviate immediate fire or sanitation hazards, or unless done with reclaimed wastewater.
- (10) The operation of any ornamental fountain or similar structure is prohibited, unless done with reclaimed wastewater.
- (11) The use of water for construction, commercial, manufacturing or processing purposes shall be reduced in volume by 50%, unless done with reclaimed wastewater.
- (12) No water will be used for air conditioning purposes.
- (13) All sales of non-reclaimed water outside of the City limits shall be discontinued, with the exception of sales previously approved by the City Council.

# SEC. 67.38.6 MANDATORY CONSERVATION PHASE IMPLEMENTATION.

The Water Utilities Department shall monitor the projected supply and demand for water, by its customers, on a daily basis during periods of emergency or drought and shall recommend to the City Manager the extent of the conservation required through the implementation and/or termination of particular conservation stages to prudently plan and supply water to its customers. Thereafter, the City Manager may order the implementation or termination of the appropriate phase of water conservation in accordance with the applicable provisions of this Chapter. Said order shall be made by public announcement and shall be published a minimum of one (1) time for three (3) consecutive days in a daily newspaper of general circulation. The stage designated shall become effective immediately upon such publication.

#### SEC. 67.38.7 PENALTY.

Violation by any person, corporation or association of the provisions of this ordinance shall constitute an offense, and, upon conviction, shall be punished by a fine not to exceed Six Hundred Dollars (\$600.00). The violation of each provision, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly, provided, however, that compliance may be further sought through injunctive relief in the Superior Court.

#### SEC. 67.38.8 SEVERABILITY.

If any provision, section, subsection, sentence, clause or phrase of this ordinance, or the application of same to any person or set of circumstances, is for any reason held to be unconstitutional, void or invalid, the invalidity of the remaining portions of this Ordinance shall not be affected, it being the intent of the City Council in adopting this Ordinance that no portions, provisions or regulations contained herein shall become inoperative, or fail by reason of the unconstitutionality of any other provision hereof, and all provisions of this Ordinance are declared to be severable for that purpose.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

It is hereby declared that, because of the conditions prevailing in the City of San Diego, the general welfare requires that the City maximize the beneficial use of its available water resources available to the City be put to the maximum beneficial use to the extent to which they are capable, and that the waste or unreasonable use, or unreasonable method of use of water be prevented and the conservation of such water is to be extended with a view to the reasonable and beneficial use thereof in the interests of the people of the City of San Diego and for the public welfare.

#### SEC. 67.38.3 AUTHORIZATION.

The City Manager, or his designate, upon the recommendation of the Director of the Water Utilities

Department, and following a public hearing notice on the situation; is hereby authorized and directed to implement the applicable provisions of this Chapter upon his determination that such implementation is necessary to protect the public welfare and safety under the following conditions:

- water emergency such as an earthquake, aqueduct break, or other major disruption in the water supply, the City Manager, or his designate, is authorized to implement the emergency provisions of this Ordinance as provided herein. Public notice will follow enactment of said provision.
- b. In the event of a foreseeable water emergency such as extended drought conditions, the City Manager, or his designate, may be authorized to implement the applicable provisions of this Ordinance as provided herein, after holding a public hearing before the City Council.
- SEC. 67.38.4 APPLICATION.

SEC. 67.38.5 WATER CONSERVATION STAGES.

First paragraph - No change.

(a) Stage 1. Normal Supply Level Available.

Stage 1 applies during periods when a normal supply and distribution capacity is available, while at the same time demand levels are not expected to significantly increase in the immediate future. All elements of Stage 2 shall during Stage 1 apply on a voluntary basis only.

Elements of Stage 1 include:

(1) Implementation of the City's Urban Water
Management Plan and Conservation Program.

- (2) Adoption of a Council Policy which is an Action Plan for Implementation of Water Conservation Techniques.
- (3) Failure to repair a controllable leak is defined as "waste of water" and is prohibited.
- (b) Stage 2. Mandatory Compliance-Water Alert.

Upon implementation by the City Manager and publication of notice, the following restrictions shall apply to all persons.

Elements of Stage 2 include:

- (1) Irrigation utilizing individual sprinklers or sprinkler systems for lawns, gardens, landscaped areas, trees, shrubs or other plants is prohibited except on a designated days and hours. which shall be once every five (5) days, and only then during the hours of 6:00 orm; to 11:00 arm; provided, however, i Irrigation of lawns, gardens, landscaped areas, trees, shrubs or other plants is permitted at anytime if:
  - (a) a hand-held hose is used, or
  - (b) a hand-held, faucet filled bucket of five(5) gallons or less is used, or
  - (c) a drip irrigation system is used, or
  - (d) reclaimed wastewater is used.

EXCEPTION: Commercial nurseries, commercial sod farmers and similarly situated establishments are exempt from Stage 2 irrigation restrictions but will be requested to curtail all nonessential water use.

(2) The washing of automobiles, trucks, trailers, boats, airplanes and other types of mobile equipment, unless wash water is recycled or reclaimed wastewater is used, is prohibited except during designated hours on designated irrigation days. between the hours of 6:00 p.m. and 11:00 a.m. Such washing, when allowed, shall be done with a hand-held bucket or a hand-held hose equipped with a positive shutoff nozzle for quick rinses. The nozzle shall be removed when the hose is not in use.

EXCEPTION: Washing may be done at any time on the immediate premises of a commercial car wash or commercial service station or with reclaimed wastewater. Further, such washings are exempted from these regulations where the health, safety and welfare of the public is contingent upon frequent vehicle cleanings, such as garbage trucks and vehicles to transport food and perishables.

- (7) Water shall not be used to wash down sidewalks, driveways, parking areas, tennis courts, patios or other paved areas, except to alleviate immediate fire or sanitation hazards or unless done with reclaimed wastewater is used.
  - (c) Stage 3. Mandatory Compliance-Water Warning.

Upon implementation by the City Manager and publication of notice, the following restrictions shall apply to all persons.

Elements of Stage 3 include:

(1) All outdoor irrigation of vegetation shall occur only between the hours of 11:00 p.m. and 9:00 a.m. during designated hours on designated days and must utilize hand-held hoses, drip irrigation or hand-held buckets.

EXCEPTION: Permanently installed sprinkler systems may be used only during the designated hours of 11:00 p.m. and 7:00 a.m. on designated days; however, irrigation using reclaimed wastewater is not subject to irrigation prohibitions.

- trailers, boats, airplanes and other types of mobile equipment not occurring upon the immediate premises of commercial car washes and or commercial service stations and not in the immediate interest of the public health, safety and welfare shall be prohibited, unless done with reclaimed wastewater is used or wash water is recycled.
- (3) The filling, refilling or adding of water to uncovered outdoor swimming pools, wading pools or spas is prohibited.
- (4) The watering of all golf course areas, except greens, is prohibited unless done with reclaimed wastewater. Irrigation of golf greens shall occur enty between the during designated hours, of 11:00 p.m. and 6:00 a.m. unless done with reclaimed wastewater.
- (5) Use of water from fire hydrants shall be limited to fire fighting and/ or other activities immediately necessary to maintaining the health, safety and welfare of the citizens of San Diego.
- (6) All restaurants are prohibited from serving water to their customers except when specifically requested by the customers.
- (7) Water shall not be used to wash down sidewalks, driveways, parking areas, tennis courts, patios or other paved areas, except to alleviate immediate fire or sanitation hazards or unless done with reclaimed wastewater is used.

(8) The operation of any ornamental fountain or similar structure is prohibited, unless <u>done with</u> reclaimed wastewater is used.

Upon implementation by the City Manager and publication of notice, the following restrictions shall apply to all persons.

Elements of Stage 4 include:

- (1) All outdoor irrigation of vegetation shall be allowed only between the <u>during designated</u> hours of 11:00 p.m. and 6:00 a.m. on designated days, unless done with reclaimed water.
- (2) Commercial nurseries, commercial sod farmers and similarly situated establishments shall water only on designated days between the during designated hours of 6:00 a.m. and 11:00 a.m. and shall use only hand-held buckets, hoses or drip irrigation unless done with reclaimed water.
- trailers, boats, airplanes and other types of mobile equipment not occurring upon the immediate premises of commercial car washes and or commercial vehicle service stations and not in the immediate interest of the public health, safety and welfare shall be prohibited, unless done with reclaimed water or wash water is recycled.
- (4) The washing of automobiles, trucks, trailers, boats, airplanes or other types of mobile equipment upon the immediate premises of commercial car

washes and or commercial vehicle service stations in the immediate interest of the public health, safety and welfare, shall occur only between the during designated hours of 12:00 noon and 6:00 p.m., unless done with reclaimed water.

- (5) The filling, refilling or adding of water to swimming pools, wading pools or spas is prohibited.
- (6) The watering of all golf course areas, except greens, is prohibited unless done with reclaimed wastewater. Irrigation of golf greens shall occur only between the <u>during designated</u> hours, of 11:00 p-m- and 6:00 a-m- unless done with reclaimed wastewater.
- (7) Use of water from fire hydrants shall be limited to fire fighting and or other activities immediately necessary to maintain ing the health, safety and welfare of the citizens of San Diego.
- (8) <u>All</u> restaurants are prohibited from serving water to their customers except when specifically requested by the customers.
- (9) Water shall not be used to wash down sidewalks, driveways, parking areas, tennis courts, patios or other paved areas, except to alleviate immediate fire or sanitation hazards, or unless done with reclaimed wastewater.
- (10) The operation of any ornamental fountain or similar structure is prohibited, unless done with reclaimed wastewater.

- (11) The use of water for construction, commercial, manufacturing or processing purposes shall be reduced in volume by 50%, unless done with reclaimed wastewater.
- (12) No water will be used for air conditioning purposes.
- of the City limits shall be discontinued, with the exception of the City of Bel Mar and the Cal-American Water District sales previously approved by the City Council.

## SEC. 67.38.6 MANDATORY CONSERVATION PHASE IMPLEMENTATION.

The Water Utilities Department shall monitor the projected supply and demand for water, by its customers, on a daily basis during periods of emergency or drought and shall recommend to the City Manager the extent of the conservation required through the implementation and/or termination of particular conservation stages in order for the Department to prudently plan for and supply water to its customers. Thereafter, the City Manager may order that the implementation or termination of the appropriate phase of water conservation be implemented or terminated in accordance with the applicable provisions of this Chapter. Said order shall be made by public announcement and shall be published a minimum of one (1) time for three (3) consecutive days in a daily newspaper of general circulation and shall continue to be

published on a daily basis until such time as all restrictions are removed and . The stage designated shall become effective immediately upon such publication.

### SEC. 67.38.7 PENALTY.

Violation by A any person, corporation or association violating any of the provisions of this ordinance shall constitute an offense, and, upon conviction, shall be punished by a fine not to exceed Six Hundred Dollars (\$600.00). The violation of each provision, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly, provided, however, that compliance may be further sought through injunctive relief in the Superior Court.

## SEC. 67.38.8 SEVERABILITY.

If any provision, section, subsection, sentence, clause or phrase of this ordinance, or the application of same to any person or set of circumstances, if is for any reason is held to be unconstitutional, void or invalid, the invalidity of the remaining portions of this Ordinance shall not be affected thereby, it being the intent of the City Council in adopting this Ordinance that no portions thereof, or provisions, or regulations contained herein shall become inoperative, or fail by reason of any the unconstitutionality of any other portion provision hereof, and all provisions of this Ordinance are declared to be severable for that purpose.
