AN ORDINANCE AMENDING ORDINANCE NO. O-16908 (NEW SERIES), ORDINANCE NO. O-16940 (NEW SERIES) AND ORDINANCE NO. O-17015 (NEW SERIES) REGULATING FOR AN INTERIM PERIOD DEVELOPMENT IN THE URBANIZED, PLANNED URBANIZING AND FUTURE URBANIZING AREAS OF THE CITY AS DEFINED IN THE PROGRESS GUIDE AND GENERAL PLAN (ADOPTED FEBRUARY 26, 1979) BY AMENDING SECTION 2.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Ordinance No. O-16908 (New Series), Ordinance No. O-16940 (New Series) and Ordinance No. O-17015 (New Series) entitled "AN ORDINANCE OF THE CITY OF SAN DIEGO REGULATING FOR AN INTERIM PERIOD DEVELOPMENT IN THE URBANIZED, PLANNED URBANIZING AND FUTURE URBANIZING AREAS OF THE CITY AS DEFINED IN THE PROGRESS GUIDE AND GENERAL PLAN (ADOPTED FEBRUARY 26, 1979)" be and the same is hereby amended by amending Section 2 to read as follows:


