AN ORDINANCE AMENDING ORDINANCE NO. 0-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17122-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE CITY ATTORNEY'S OFFICE (045) TWO (2.00) DEPUTY CITY ATTORNEY POSITIONS, ONE (1.00) LEGAL ASSISTANT POSITION, AND ONE (1.00) LEGAL SECRETARY POSITION; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$126,625 IN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) TO THE CITY ATTORNEY'S OFFICE (045), ALL IN CONNECTION WITH PROVIDING LEGAL SUPPORT IN REGARD TO THE PROPOSED MERGER BETWEEN SOUTHERN CALIFORNIA EDISON AND SAN DIEGO GAS & ELECTRIC COMPANY.

WHEREAS, San Diego Gas & Electric Company has declared its approval for merger with the Southern California Edison Company; and

WHEREAS, such corporate merger is deemed by the City Council not to be in the best interest of the people of San Diego; and WHEREAS, such action will also result in the loss of at least 1,000 jobs to San Diegans; and

WHEREAS, The City of San Diego is firmly committed to opposing said action with all vigor and legal recourse; and

WHEREAS, this effort will require the full attention of legal staff, at a minimum of two attorneys and necessary legal support; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to effectuate provision of said additional legal staff support and related expenses; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as amended and adopted therein, by amending the personnel authorization schedule for the City Attorney's office (045) to reflect therein the addition of (2.00) Deputy City Attorney positions, one (1.00) Legal Assistant position and one (1.00) Legal Secretary position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100, the sum of \$126,625 from the Unallocated Reserve (605) to the City Attorney's office (045) for the additional personnel authorized in section 1 above and related costs [\$10,000 in increased travel and \$25,000 in special counsel costs] for the second half of fiscal year 1988-89.

Section 3. That the City Manager be and he is hereby directed to make necessary and appropriate provision for inclusions of the positions authorized in section 1 above in the fiscal year 1989-90 appropriation ordinance, with additional non-personal expense allocation as determined by the City Manager and City Attorney.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

The ordinance also authorizes the Auditor and Comptriller to transfer \$128,825 from the Unallocated Reserve (805) to the City Attorney's budget (045) to fund said position for the remainder of fiscal year 1988-89 and provide funds for related non-personal expenses.
