ORDINANCE NUMBER O- 17226 (NEW SERIES)

ADOPTED ON JAN 23 1989

AN ORDINANCE ESTABLISHING A PARKING METER
ZONE ON THE NORTH SIDE OF DATE STREET
BETWEEN FRONT STREET AND UNION STREET.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Pursuant to the authority of Section 22508 of the California Vehicle Code and in accordance with the provisions of Section 86.11 of the San Diego Municipal Code, a parking meter zone is hereby established on the north side of Date Street between Front Street and Union Street. The above described meters shall be in parking meter Zone A as described in Section 86.13 of the San Diego Municipal Code.

Section 2. A parking time limit of two hours shall be in effect in the above described location between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, as provided in Section 86.16 of the San Diego Municipal Code.

Section 3. The installation of parking meters and the necessary signs and markings be, and the same is hereby authorized to be made in the above described location.

Section 4. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage.

AN ORDINANCE SETTING ASIDE AND DEDICATING PARCEL B, BEING LOT 134, VIEW RIDGE UNIT 3, MAP NO. 11693, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel B, being Lot 134, View Ridge Unit 3, Map No. 11693, which is by this reference incorporated herein, is hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Council of The City of San Diego hereby specifically reserves the right to establish underground public service easements through and across the dedicated property so long as the construction and maintenance of the subject easements do not substantially negatively impact the availability of the property for use for park and recreational purposes.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a Certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


