The area to which the provisions of this division are applicable is shown on those certain Map Drawing Nos. C-670.4, C-671.1, C-676.4, C-679.2, C-683.1, C-694 and C-698.2, and described in the appended boundary description filed in the office of the City Clerk under Document Nos. 00-16636, 00-16718, 00-16729, 00-17050 and 00-17245.

Section 2. That Ordinance No. 0-16975 (New Series), adopted November 9, 1987, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
