## ordinance number o-17246 (New Series) Adopted on FEB 2 1 1989

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6, SECTION 26.07 OF THE SAN DIEGO MUNICIPAL CODE RELATING TO TERMS OF OFFICE FOR ALL MEMBERS OF THE COMMISSION FOR ARTS AND CULTURE.

WHEREAS, the first members of the Commission for Arts and Culture were appointed on August 8, 1988; and

WHEREAS, the term of such Commissioners presently expires on March 31; and

WHEREAS, such expiration date of March 31 does not allow all Commissioners to complete one full year term; and

WHEREAS, a change of the expiration date to August 31 would allow Commissioner terms to end at the completion of a funding cycle rather than in the middle of the allocation process; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 6, Section 26.07 B of the San Diego Municipal Code be and the same is hereby amended by amending Section 26.07 to read as follows:

## SEC. 26.07 COMMISSION FOR ARTS AND CULTURE

- A. PURPOSE AND INTENT no change
- B. COMMISSION FOR ARTS AND CULTURE ESTABLISHED

There is hereby established a Commission for Arts and Culture consisting of fifteen (15) members. Commission members shall be persons who represent the following areas:

individual arts, arts organizations, arts patrons, educators, the business community, and the general public.

The members shall serve three (3) year staggered terms for a maximum of six (6) years and each member shall serve until a successor is duly appointed and confirmed. interval of four (4) years must pass before such persons can be reappointed. The members shall be appointed by the Mayor and confirmed by the City Council, subject to the following conditions: 1) the Mayor shall appoint seven (7) members; and 2) the Mayor shall appoint the remaining eight (8) members, one each from a list of three (3) nominations submitted by each Councilmember. The members shall be appointed in such a manner that the terms of not more than five (5) members shall expire in any one year. The expiration date of all terms shall be August 31. During September of each year, the Mayor may designate one (1) member as chairperson; however, in the absence of such designation, the Commission shall on or after October 15 select from their members a chairperson. The Commission shall meet not less than monthly and report to the Mayor and Council on an as-needed basis, but not less than one time per year.

The Commission shall adopt rules consistent with laws for the government of its business and procedures.

C. DUTIES AND FUNCTIONS - no change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
