ORDINANCE NUMBER O- 17249 (NEW SERIES)

ADOPTED ON FEB 21 1989

AN ORDINANCE ESTABLISHING A PARKING METER
ZONE ON THE EAST SIDE OF FALCON STREET
BETWEEN WASHINGTON STREET AND THE ALLEY
SOUTH OF WASHINGTON STREET.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Pursuant to the authority of Section 22508 of the California Vehicle Code and in accordance with the provisions of Section 86.11 of the San Diego Municipal Code, a parking meter zone is hereby established on the east side of Falcon Street between Washington Street and the alley south of Washington Street. The above described meters shall be in parking meter Zone A as described in Section 86.13 of the San Diego Municipal Code.

Section 2. A parking time limit of two hours shall be in effect in the above described location between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, as provided in Section 86.16 of the San Diego Municipal Code.

Section 3. The installation of parking meters and the necessary signs and markings be, and the same is hereby authorized to be made in the above described location.

Section 4. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage.
