ORDINANCE NUMBER O- 17256 (NEW SERIES)

ADOPTED ON FEB 28 1989

AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY REDUCING THE CAPITAL IMPROVEMENTS PROGRAM IN THE AMOUNT OF \$2.2 MILLION, SAID SUM TO COME FROM THE NEW CONVENTION FACILITY (10225) CIP 54-006.0, ENTITLED "PEDESTRIAN BRIDGES," DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER SAID \$2.2 MILLION TO SAN DIEGO FESTIVALS, INC. - TOT CONTRIBUTIONS (91141), FOR THE SOLE AND EXCLUSIVE PURPOSE OF FUNDING THE SOVIET ARTS FESTIVALS.

WHEREAS, it is proposed that the annual appropriation ordinance be amended to transfer the sum of \$2.2 million from the New Convention Facility (10225) CIP No. 54-006.0, entitled "Pedestrian Bridges" to the Special Promotional Programs (10224) for allocation to the San Diego Festivals, Inc. - TOT contributions (91141), for the sole and exclusive purpose of funding the 1989 San Diego Arts Festival; and

WHEREAS, it is planned to replace said sum in full during FY 1990 with funding preliminarily allocated to the FY 1990 Special Promotional Programs Budget in the Arts/Cultural Festivals category; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, by transferring the sum of \$2.2 million from the New Convention Facility (10225), CIP No. 54-006.0, entitled "Pedestrian Bridges" to the Special Promotional Programs (10224) for allocation to the San Diego Festivals, Inc. - TOT Contributions (91141) for the sole and exclusive purpose of funding the 1989 San Diego Arts Festival.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
