AN ORDINANCE INCORPORATING 0.75 ACRES LOCATED ON THE SOUTH SIDE OF CALLE CRISTOBAL BETWEEN THE FUTURE ALIGNMENT OF CAMINO SANTA FE ON THE WEST AND CAMINITO LA BAR, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-5000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, AND REPEALING ORDINANCE NO. 0-10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 0.75 acres located on the south side of Calle Cristobal between the future alignment of Camino Santa Fe on the west and Caminito La Bar, in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R1-5000" on Zone Map Drawing No.

B-3893, filed in the office of the City Clerk as Document No.

DD-17260, be, and it is hereby incorporated into R1-5000 Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0407.

Section 2. This ordinance shall not become effective until thirty (30) days from and after its passage or until thirty (30) days from and after this rezoning is certified, as submitted, as a Local Coastal Program amendment by the California Coastal Commission, whichever date later occurs. If the rezoning is not certified, as submitted, by the California Coastal Commission, this ordinance shall not become effective.
