AN ORDINANCE AMENDING ORDINANCE NO. 0-17098 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1988-89" BY AMENDING EXHIBIT B THERETO TO CREATE AND ADD A NEW CLASS ENTITLED, "EMPLOYEE BENEFITS SPECIALIST II" IN THE MANAGEMENT, FISCAL AND STAFF OCCUPATIONAL GROUP AND RETITLE THEREIN "EMPLOYEE BENEFITS SPECIALIST" TO READ "EMPLOYEE BENEFITS SPECIALIST I"; AMENDING EXHIBIT A-2 OF SAID ORDINANCE TO PROVIDE A NEW SALARY RATE NUMBER 40.7 FOR SAID NEW POSITION IN THE CLASSIFIED SERVICE, AS SET FORTH IN ATTACHMENT A HERETO; AMENDING RESOLUTION NO. R-270952 TO PLACE THE NEWLY CREATED CLASSES IN THE NO REPRESENTATION UNIT; AMENDING RESOLUTION NO. R-270951 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASSES AS INELIGIBLE FOR OVERTIME BY PLACING THEM IN GROUP F OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-270951; AND AMENDING RESOLUTION NO. R-271228 TO AUTHORIZE THESE CLASSES TO RECEIVE MANAGEMENT BENEFITS CONSISTENT WITH OTHER UNREPRESENTED CLASSES.

WHEREAS, staff is recommending that a new higher level classification of Employee Benefits Specialist II be created for two positions in the Risk Management Department; and

WHEREAS, as the result of a classification study, it was found that these positions, which are currently classified as Employee Benefits Specialist, are performing duties of a higher level than originally envisioned for the existing Employee Benefits Specialist class; and

WHEREAS, since the Employee Benefits Specialist classification was established in 1985, the duties and

responsibilities of these positions have increased significantly for a number of reasons which include changes in department management, a reorganization within the Employee Benefits Division, an increase in benefit plans available to City employees, and increased legislation which impacts benefit plans and programs; and

WHEREAS, based on the higher level of independence and increased level of analysis required of these positions, it is recommended that a higher level class of Employee Benefits Specialist II be created at a salary equal to Associate Administrative Analyst (\$2,553 - \$3,084 per month); and

WHEREAS, staff also recommends that the title of the current Employee Benefits Specialist classification be changed to Employee Benefits Specialist I; and

WHEREAS, it is also recommended that this class be placed in the "No Representation Unit" with the existing Employee Benefits Specialist class; and

WHEREAS, it is recommended that the Overtime Resolution be amended to place this new class in Group F and Resolution No. R-271228 be amended to designate this class as eligible to receive the Management Benefits Plan; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17098 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1988-89," be and the same is hereby amended

by amending Exhibit B thereto by creating and adding a new class, entitled "EMPLOYEE BENEFITS SPECIALIST II" in the Management, Fiscal and Staff Occupation Group, at a salary rate number 40.7.


Section 2. That the existing class of Employee Benefits Specialist in Exhibit B be and the same is hereby retitled to read "Employee Benefits Specialist I."

Section 3. That Exhibit A-2 of the above-cited ordinance be amended to include a new salary rate number 40.7, ranging from \$2,553 to \$3,084 per month, at rates and steps as set forth in Attachment A hereto.

Section 4. That Resolution No. R-270952, be and it is hereby amended to place the newly created classes in the No Representation Unit.

Section 5. That Resolution No. R-270951, be and it is hereby amended by approving and declaring the newly created classes as ineligible for overtime and placing said newly created classes in Group F of said Overtime Eligibility Resolution No. R-270951.

Section 6. That Resolution No. R-271228 be amended to authorize the above newly established classes to receive Management Benefits consistent with other unrepresented classes.



Section 7. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
