AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, TO ESTABLISH A SPECIAL FUND TO BE ENTITLED "REGY YOUTH INCENTIVE FUND," (NO. 10591), SAID FUND TO EARN AND BE CREDITED WITH INTEREST EARNINGS IN PROPORTION TO TOTAL EARNINGS RECEIVED BY THE CITY; AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO ACCEPT FOR DEPOSIT AND TO DISBURSE MONIES FROM THIS FUND, AS DIRECTED.

WHEREAS, the City's Regional Youth Employment Program (REGY) recently began operation of a new career exploration program for low-income youths who are in school; and

WHEREAS, the young people will be assigned to work after school in City departments and other public agencies as unpaid volunteers, where they will learn about the skills, education, and training necessary to be successful in a career area of their interest; and

WHEREAS, REGY will be seeking donations from private sources which can be used to provide incentives to the youths, who will not be paid for their work, but will earn these incentive awards for completion of specific job related competencies; and

WHEREAS, it is anticipated that donations will be received in the form of cash, gift certificates, and merchandise from a variety of businesses throughout the community; and

WHEREAS, it is proposed that a special Youth Incentive Fund be established to deposit cash donations, and the funds will be spent to provide cash awards or other incentives to youths on the basis of merit and achievement; and

WHEREAS, the Youth Incentive Fund will be used to serve youths not only in the career exploration program, but also in future REGY programs as well and will provide REGY with the flexibility in motivating young people to learn and to succeed in the world of work; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1 as amended and adopted therein, to establish a special fund to be entitled "REGY Youth Incentive Fund," (No. 10591), said fund to earn and be credited with interest earnings in proportion to total earnings received by the City.

Section 2. That the Auditor and Comptroller be and he is hereby directed to accept for deposit into and disburse monies from this fund as directed.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
