AN ORDINANCE AMENDING ORDINANCE NO. 0-16855 (NEW SERIES), ADOPTED ON MAY 4, 1987 AND WAS EXTENDED ON APRIL 4, 1988, RELATING TO LIMITING THE ISSUANCE OF BUILDING PERMITS AND DEMOLITION PERMITS IN PORTIONS OF UPTOWN, FOR THE PURPOSE OF EXTENDING THE EFFECTIVE DATE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 9 of Ordinance No. O-16855 (New Series) adopted on May 4, 1987, and was extended on April 4, 1988 by Ordinance No. O-17052 (New Series) to expire on May 4, 1989, be and the same is hereby amended for the purpose of extending the effective date to read as follows:

Section 9. The provisions of this ordinance shall remain in force and effect until the zoning implementation for the revised Uptown Community Plan is in effect, unless it is extended by act of this City Council or is superseded by new legislation.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
