AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.0102 RELATING TO PUBLICATION OF ORDINANCES OR RESOLUTIONS.

WHEREAS, the San Diego Municipal Code, section 22.0102, states that an ordinance or resolution of a general nature shall be published within ten days after final passage; and

WHEREAS, the San Diego City Charter, section 18, states that an ordinance or resolution of a general nature shall be published within fifteen days after final passage; and

WHEREAS, this amendment to the San Diego Municipal Code, section 22.0102, will bring it into conformance with the San Diego City Charter, section 18; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, of the San Diego Municipal Code be and the same is hereby amended to read as follows:

## SEC. 22.0102 PUBLICATION OF ORDINANCES OR RESOLUTIONS

Within fifteen (15) days after final passage of any ordinance or resolution of a general nature, the City Clerk shall cause the same to be published once in the "City Official Newspaper" as defined by Section 113

of the Charter; provided, however, that when any ordinance or resolution is, by the City Charter, or by any general law, the provisions of which have been adopted by the Charter, required to be published more than once, the City Clerk shall cause such ordinance or resolution to be published in the manner and as often as is so required.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
