AN ORDINANCE AMENDING THE SAN DIEGO MUNICIPAL CODE BY AMENDING CHAPTER II, ARTICLE 6, DIVISION 2, SECTION 26.02 RELATING TO THE HISTORICAL SITE BOARD; RENUMBERING SECTION 26.02 TO 26.0201 ET SEQ.; CORRECTING SECTIONS 103.0203, 103.1204, 103.1606 TO REFLECT RENUMBERED SECTIONS.

WHEREAS, an amendment to San Diego Municipal Code (SDMC) section 26.02 would allow the appeal process to conform to other sections of the municipal code relating to appeal processes (i.e., SDMC section 101.0240) which do not reference a time period relative to the scheduling of a hearing; and

WHEREAS, the City Clerk's office relies on the originating department for the material necessary to schedule the appeal for Council hearing; and

WHEREAS, deletion of "within 15 days" would allow both the originating department and the Clerk's office time to compile the necessary documentation; and

WHEREAS, the addition of "applicant" would ensure that the applicant would be notified of the hearing in those cases when the appellant is someone other than the applicant; and

WHEREAS, it is also appropriate to renumber the code sections to accomplish the project of conforming the sections to the municipal code; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 6, Division 2 of the San Diego Municipal Code be and the same is hereby amended by amending and renumbering section 26.02 to read, as follows:

SEC. 26.0201 PURPOSE AND INTENT

SEC. 26.0204 DUTIES AND FUNCTIONS

Change subsections 1. through 7. to read

A through G, respectively. (No change in text

A. through F.)

G. The action of the Historical Site
Board in designating any historical site as
defined in paragraph "C" shall be final on the
eleventh (11th) day following the decision of
the Historical Site Board unless an appeal to
the City Council is filed with the City Clerk
within ten (10) days of the action by the
Historical Site Board. Such appeal shall be
in writing and shall specify wherein there was
error in the decision of the Board. Upon the
filing of the appeal the Clerk shall set the

matter for public hearing as soon thereafter as its practicable and shall give written notice to the appellant and applicant of the time and date set for the hearing. Upon the hearing of such appeal, the City Council may by resolution affirm, reverse or modify the determination of the Board.

SEC. 26.0205 DEMOLITION, ALTERATION OR REMOVAL OF HISTORICAL SITES

SEC. 26.0206 NOMINATIONS FOR THE NATIONAL REGISTRY OF HISTORICAL PLACES

Section 2. That section 103.0203B.3. and 103.0203B.4. be and the same are hereby amended to change the references to section 26.02E to read section 26.0205.

Section 3. That section 103.1204 be and the same is hereby amended to change all references therein to section 26.02 to read section 26.0201, et seq.

Section 4. That section 103.1606D.4.b. be and the same is hereby amended to change the reference to section 26.02 to read section 26.0201 et seq.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING THE SAN DIEGO MUNICIPAL GODE BY AMENDING CHAPTEN II, ARTICLE 6, DIVISION 2, SECTION 28.02 RELATING TO THE HISTORICAL SITE SOARD; RENUMBERING SECTION 26.02 TO 26.0201 ET SEC. CORRECTING SECTIONS 103.0203, 103.1204, 103.1606 TO REFLECT RENUMBERED SECTIONS.

This ordinance amends section 26.02 of the San Diego Municipal Code relating to appeals from decisions of the Historical Site Board by deleting the litteen (15) day time period within which a hearing must be scheduled and substituting a "reasonable time" in lieu thereof. This makes this appeal period consistent with all other appeal provisions. The ordinance also renumbers section 26.02 to read 25,0201 of seq. to conform with the numbering scheme of other sections in the municipal code. Finally, sections 103,0203, 103,1204, and 103,1606 are corrected to reflect therein the renumbered sections.
