AN ORDINANCE INCORPORATING 28.3 ACRES, LOCATED SOUTH OF AERO DRIVE, EAST OF RUFFIN ROAD AND WEST OF DALEY DRIVE, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-IP ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0435.1, AND REPEALING ORDINANCE NO. 8660 (NEW SERIES), ADOPTED JUNE 14, 1962, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance incorporating 28.3 acres, located south of Aero Drive, east of Ruffin Road and west of Daley Drive, in the Serra Mesa Community Plan area, in the City of San Diego, California, designated "M-IP" on Zone Map Drawing No. B-3873, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0435.1 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into M-IP Zone, as described and defined by Section 101.0435.1, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3873, filed in
