ADOPTED ON MAY 1 1989

AN ORDINANCE INCORPORATING 9.7 ACRES, LOCATED ON THE SOUTH SIDE OF ENTREKEN WAY, BETWEEN CARMEL MOUNTAIN ROAD AND RUSSET LEAF LANE, IN THE PENASQUITOS EAST COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CN AND R1-5000 ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0426 and 101.0407 AND REPEALING ORDINANCE NO. 8858 (NEW SERIES), ADOPTED JULY 18, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance incorporating 9.7 acres, located on the south side of Entreken Way, between Carmel Mountain Road and Russet Leaf Lane, in the Penasquitos East Community Plan area, in the City of San Diego, California, designated "CN and R1-5000" on Zone Map Drawing No. B-3892, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Sections 101.0426 and 101.0407 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into CN and R1-5000 Zones, as described and defined by Sections 101.0426 and 101.0407, the boundary of such zone to

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
