

ORDINANCE NUMBER 0- 17296 (NEW SERIES)

ADOPTED ON MAY 15 1989

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 22.0517, RELATING TO PURCHASING AGENT.

Section 1. WHEREAS the volume of material disposed of at City sanitary landfills has been increasing annually, and

WHEREAS sanitary landfill space is at a premium, and it is becoming increasingly difficult to site new landfills, and

WHEREAS much of the material that enters the wastestream can be recycled and reused or incorporated in the manufacture of new products, and

WHEREAS City participation in and promotion of recycling programs can significantly reduce the volume of material entering the wastestream thereby extending City landfill life expectancy and reducing expenses, and

WHEREAS, for recycling programs to be effective, markets must be developed for products which incorporate post consumer materials in their manufacture.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of San Diego as follows:

That Chapter II, Article 2, Division 5, of the San Diego Municipal Code be and the same is hereby amended by adding Section 22.0517, to read as follows:

SEC. 22.0517

PURCHASING POLICY: RECYCLED PRODUCTS

A. PURPOSE AND INTENT

It is the intent of the City Council that the City of San Diego take a leadership role not only in recycling its waste products but also in the purchase of recycled products for use in the delivery of City services. It is the purpose of this section to provide direction to the City Manger and the Purchasing Agent in the procurement and use of recycled products.

B. POLICY

1. It is the policy of the City of San Diego to purchase and use recycled products whenever possible to the extent that such use does not negatively impact health, safety, or operational efficiency.
2. Purchase of products which cannot be recycled or reused is strongly discouraged.
3. Recycled paper shall be purchased and used in all copy machines which will accept it and shall also be used for printing purposes. City staff will encourage the copier industry to develop high-speed copiers which will accept recycled paper.

City departments and divisions shall use for their mast-head stationery and envelopes recycled paper which includes both secondary and post-consumer recycled content. The percentages of post-consumer and secondary content shall be spelled out in the bid specifications for

letterhead and other paper grades based on industry availability. A recycled paper designation shall be printed on all City stationery.

4. City departments shall examine their purchasing specifications and, where feasible, restructure them to require the use of products which incorporate recycled materials in their manufacture.
5. A ten percent (10%) preference, not to exceed \$1,000.00 per contract, may be given to recycled products. The preference percentage shall be based on the lowest bid or price quoted by the supplier or suppliers offering nonrecycled products.
6. The City shall cooperate with the County of San Diego, SANDAG and other governmental agencies in the development of programs and procedures which will further this policy.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

**ORDINANCE NUMBER O-17296 (NEW SERIES)**

**AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 2.0517, RELATING TO PURCHASING AGENT.**

This ordinance sets forth a procurement policy relative to recycled products. It establishes as City policy the purchase and use of recycled products whenever possible when health, safety or operational efficiency would not be impaired. It discourages the purchase of nonrecyclable products and requires City departments to restructure their purchasing specifications to require products which incorporate recycled materials in their manufacture, when feasible. It sets forth specific requirements for recycled paper use. It also allows a ten percent preference for recycled products, up to \$1,000 per contract and mandates cooperation with other governmental agencies in the furtherance of recycling efforts.
