AN ORDINANCE REPEALING ORDINANCE NO. 0-17201

WHEREAS, the Council of The City of San Diego on January 9, 1989 adopted Ordinance No. O-17201 (New Series) entitled "AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING THE DEVELOPMENT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND BCE DEVELOPMENT, INC."; and

WHEREAS, on February 7 and 8, 1989 a Referendary Petition requesting the City Council to repeal or rescind Ordinance No. 0-17201 (New Series) or submit said ordinance to the registered voters of the City for their approval or rejection was filed in the office of the City Clerk as Document No. 1273258; and

WHEREAS, the City Clerk has found the Referendary Petition to contain the requisite number of valid signatures and to be in proper form and has so certified, with certification attached, to the City on March 6, 1989; and

WHEREAS, pursuant to San Diego Municipal Code sections 27.2615 and 27.2616, the Council must within ten (10) days of presentation of the petition to it reconsider the ordinance, and if the Council refuses to grant the petition to repeal said ordinance or fails to reconsider the ordinance within ten (10) days after presentation by the City Clerk, then the Council shall forthwith adopt a resolution of intention to submit the matter to the people at a special election or any other election at which

all the voters of the City are entitled to vote, to be held within eleven (11) months from the date the Referendary Petition is presented to the Council; and

WHEREAS, the Council on April 17, 1989 accepted the above-referenced petition, reconsidered Ordinance No. 0-17201 (New Series), and indicated its intention to repeal the same; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That upon Council's reconsideration of Ordinance No. O-17201 (New Series), the above referenced petition is hereby granted and Ordinance No. O-17201 (New Series) is hereby repealed.

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
