AN ORDINANCE AMENDING ORDINANCE NO. O-17122 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17122-1, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SIGN CODE ENFORCEMENT PROGRAM FROM THE BUILDING INSPECTION ENTERPRISE FUND 41300, DEPARTMENT 06600, TO THE GENERAL FUND 100, DEPARTMENT 06500; DIRECTING AUDITOR AND COMPTROLLER TO INCREASE GENERAL FUND 100 APPROPRIATIONS BY \$157,000 TO COME FROM SIGN CODE PROGRAM UNANTICIPATED REVENUES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17122 (NEW SERIES), as amended entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1988-89 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17122-1, as adopted and amended therein, by transferring the Sign Code Enforcement Program from the Building Inspection Enterprise Fund 41300, Department 06600 to the General Fund 100, Department 06500.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to increase the total General Fund 100 appropriations by the sum of \$157,000, said sum to come from Sign Code Program unanticipated revenues.

Section 3. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
