AN ORDINANCE INCORPORATING VARIOUS PROPERTIES LOCATED IN AN AREA GENERALLY ALONG THE NORTH AND SOUTH SIDES OF GARNET AVENUE BETWEEN MISSION BOULEVARD AND PENDLETON STREET, IN THE PACIFIC BEACH COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE C-1 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0430, TO COMPLY WITH THE IMPLEMENTATION OF THE LOCAL COASTAL PROGRAM AND TO COINCIDE WITH THE LAND USE DESIGNATIONS IN THE PACIFIC BEACH COMMUNITY PLAN, AND REPEALING ORDINANCE NO. O-119 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That various properties located in an area generally along the north and south sides of Garnet Avenue between Mission Boulevard and Pendleton Street, in the Pacific Beach Community Plan area, in the City of San Diego, California, within the boundary of the district designated "C-1" on Zone Map Drawing No. C-789.1, filed in the office of the City Clerk as Document No. 17323, be, and they are hereby incorporated into the C-1 Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0430, to comply with the implementation of the Local Coastal Program and to coincide with the land use designations in the Pacific Beach Community Plan,

Section 2. That Ordinance No. O-119 (New Series), adopted January 3, 1933, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflicts herewith.

This ordinance shall take effect and be in force on the thirtieth day from and after the date the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance shall be null and void.

Section 4. No permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date the California Coastal Commission unconditionally certified this ordinance as a local coastal program amendment.
