AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING DIVISION 12, SECTION 42.1201 RELATING TO THE REGULATION OF THE STORAGE AND DISPOSAL OF MEDICAL WASTES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 2, of the San Diego Municipal Code be and the same is hereby amended by adding Division 12, Section 42.1201 to read as follows:

## SEC. 42.1201 San Diego County Regulation of Medical Waste Ordinance - Adoption By Reference

The following sections of the County Code of the County of San Diego, California adopted by the Board of Supervisors as Ordinance No. 7556 (New Series), one copy of which is on file in the office of the City Clerk of The City of San Diego as Document No. 00.17330, are hereby adopted as the Medical Waste Ordinance of the City of San Diego: Sections 68.501, 68.504, 68.1201, 68.1202, 68.1203, 68.1204, 68.1205, 68.1206, 68.1207, 68.1208, 68.1209, 68.1210 and 68.1211. Each and all of the regulations, provisions, conditions and

terms of said sections are hereby referred to, adopted and made a part hereof as if fully set out in this Division.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING DIVISION 12, SECTION 42.1281 RELATING TO THE REGULATION OF THE STORAGE AND DISPOSAL OF MEDICAL WASTES.

This ordinance addresses the need to regulate the disposal of blomedical hazardous waste materials in amounts less than 100 kilograms per month, since State law governs disposal of blomedical hazardous waste materials in amounts less than 100 kilograms per month, since State law governs disposal of blomedical waste excéeding that amount. The County of San Diego has enacted this same ordinance and, as the County Health Department acts as the County ordinance is being adopted by feference. The ordinance provides for regulation of storage and disposal of medical wastes, requires small generators of blohazardous wastes to make application and obtain a permit from the Deputy Director of Environmental Health Services, and provides both oriminal and civil sanctions for violation of its provisions.
