ORDINANCE NUMBER O- 17332 (NEW SERIES)

ADOPTED ON JUL 31 1989

AN ORDINANCE CALLING A GENERAL MUNICIPAL
ELECTION IN THE CITY OF SAN DIEGO ON TUESDAY,
NOVEMBER 7, 1989.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a General Municipal Election will be held in the City of San Diego on Tuesday, November 7, 1989, for the purpose of electing candidates for the following offices, unless such candidates have been elected in the Municipal Primary Election:

COUNCILMEMBER for District No. 1	four-year term
COUNCILMEMBER for District No. 3	four-year term
COUNCILMEMBER for District No. 5	four-year term
COUNCILMEMBER for District No. 7	four-year term

Section 2. For the purpose of said election, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain said precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the office of the City Clerk.

Section 3. The City Clerk shall designate the polling places, and shall appoint the members of the precinct boards for said election.

Section 4. That the polls for said election shall be open from 7 a.m. until 8 p.m. on Tuesday, November 7, 1989.

Section 5. The City Clerk is hereby directed to procure and supply the required number of ballots, sample ballots, equipment, supplies and other printed matter.

Section 6. The following rates of compensation are hereby established for said election:

Inspectors	\$50.00*
Judges	\$35.00
Clerks	\$35.00
Rental of Polling Place	\$25.00

*Compensation provides for ballot box returns.

Section 7. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 8. Pursuant to Section 17 of the Charter of The City of San Diego, this ordinance shall take effect on the date of its adoption.

AN ORDINANCE CALLING A GENERAL MUNICIPAL ELECTION IN THE CITY OF SAN DIEGO ON TUESDAY, NOVEMBER 7, 1989.

This ordinance calls for a General Municipal Election to be held in San Diego on Tuesday, November 7, 1989, for the purpose of nominating candidates for City Council districts numbers 1, 3, 5, and 7 for four-year terms. This ordinance states the manner in which precincts shall be established, specifies the duties of the City Clerk in designating polling places, and conducting the election, states the hours of operation of polling places, sets the rates of compensation for rental and staffing of polling places, and requires the City Clerk to publish this ordinance. The ordinance becomes effective on the date of its adoption pursuant to Charter Section 17.


