AN ORDINANCE AMENDING ORDINANCE NO. 0-17305 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1989-90" BY AMENDING EXHIBIT B THERETO TO CREATE AND ADD A NEW CLASS ENTITLED "SENIOR CODE COMPLIANCE SUPERVISOR" IN THE FIELD CONTACT OCCUPATIONAL GROUP; AMENDING EXHIBIT A-1 OF SAID ORDINANCE TO PROVIDE A NEW SALARY RATE NUMBER 91.2 FOR SAID POSITION IN THE CLASSIFIED SERVICE, AS SET FORTH IN ATTACHMENT A HERETO; AMENDING RESOLUTION NO. R-273664 TO PLACE THE NEWLY CREATED CLASS IN THE SUPERVISORY REPRESENTATION UNIT; AND AMENDING RESOLUTION NO. R-273663 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR REGULAR RATE OVERTIME BY PLACING IT IN GROUP C OF SAID OVERTIME ELIGIBILITY RESOLUTION NO. R-273663.

WHEREAS, the Police Department has requested a new classification to serve as a second level supervisor over the Parking Enforcement and Abandoned Vehicle Abatement Units; and

WHEREAS, this request was initiated as the result of a reorganization within the Traffic Division; and

WHEREAS, this new class will supervise the Parking
Enforcement Unit, which is responsible for City-wide enforcement
of State and local parking codes and ordinances, and the
Abandoned Vehicle Abatement Unit which is responsible for
enforcing codes and ordinances related to vehicles abandoned on
public and private property; and

WHEREAS, duties are many and varied, as set forth with specificity in the Personnel Director's Report to the Mayor and Council, dated July 7, 1989; and

WHEREAS, since there is no existing classification which encompasses the duties described above, it is recommended that a new class of Senior Code Compliance Supervisor be created at a salary rate of \$2,317 to \$2,781 per month; and

WHEREAS, this recommended salary range will provide an approximate 15% supervisory differential over the highest class regularly supervised which is consistent with the City's compensation practices for supervisory classes with similar responsibilities; and

WHEREAS, it is further recommended that this class be eligible for regular rate overtime under the same conditions as other second level supervisory classes which are listed in Group C of the Addendum to Personnel Manual Section H-4, Overtime; and

WHEREAS, included in this group are those classes designated as exempt from the overtime provisions of the Fair Labor Standards Act but eligible for regular rate overtime in accordance with City policy; and

WHEREAS, it is also recommended that this class be placed in the Supervisory Bargaining Unit; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17305 (NEW SERIES), as amended entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF

COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1989-90" be and the same is hereby further amended by amending Exhibit B thereto by creating and adding a new classification, class number 1912, entitled "SENIOR CODE COMPLIANCE SUPERVISOR" in the Field Contact Occupational Group at salary rate number 91.2.

Section 2. That Exhibit A-1 of the above cited ordinance be amended to include a new salary rate number 91.2, ranging from \$2,317 to \$2,781 per month, at rates and steps as set forth in Attachment A hereto.

Section 3. That Resolution No. R-273664 be and it is hereby amended to place the newly created class of SENIOR CODE COMPLIANCE SUPERVISOR in the Supervisory Representation Unit.

Section 4. That Resolution No. R-273663 be and it is hereby amended by approving and declaring the newly created class as exempt from the Fair Labor Standards Act and eligible for regular rate overtime and placing said newly created class in Group C Overtime Eligibility.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
