AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE ENGINEERING AND DEVELOPMENT DEPARTMENT (540), IN GENERAL FUND 100, BY ADDING ONE (1.00) DEPUTY DIRECTOR POSITION; EXEMPTING SAID DEPUTY DIRECTOR POSITION FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THERFOR.

WHEREAS, it has been proposed to add one (1.00) Deputy

Director to the Engineering and Development Department (540); and

WHEREAS, section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental policies and programs"
may be exempted from the Classified Service by ordinance upon
first having been reviewed and commented upon by the Civil
Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on July 26, 1989, and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said addition and exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17326-1, as amended and adopted therein, by adding one (1.00) Deputy Director position to the personnel authorization of the Engineering and Development Department (540).

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on July 26, 1989, the Deputy Director position authorized herein is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, identified as Exhibit C to Ordinance 17305 (New Series), dated May 30, 1989, be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
