

ORDINANCE NUMBER O- 17344 (NEW SERIES)

ADOPTED ON SEP 25 1989

AN ORDINANCE INCORPORATING AN 0.188 ACRE LOT LOCATED ON THE SOUTH SIDE OF LA CUENTA DRIVE BETWEEN TIERRASANTA BOULEVARD AND BAROQUE LANE, IN THE TIERRASANTA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO COMMERCIAL OFFICE ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0423, AND REPEALING ORDINANCE NO. 10864 (NEW SERIES), ADOPTED JULY 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That subject to recordation of a map or a certificate of compliance, an 0.188 acre lot, located on the south side of La Cuenta Drive between Tierrasanta Boulevard and Baroque Lane, in the Tierrasanta Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R1-40000" on Zone Map Drawing No. B-3912, filed in the office of the City Clerk as Document No. 00-17344, be, and it is hereby incorporated into Commercial Office Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0423.


Section 2. That Ordinance No. 10864 (New Series), adopted July 29, 1972, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
