ADOPTED ON SEP 25 1969

AN ORDINANCE INCORPORATING A PORTION OF PARCEL 9 OF PARCEL MAP NO. 8547 AND LOT 150 OF VILLA BARBADOS NORTH UNIT NO. 1, MAP NO. 7236, LOCATED SOUTH OF STATE ROUTE 52, WEST OF SANTO ROAD, IN THE TIERRASANTA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO COMMUNITY COMMERCIAL ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0427, AND REPEALING ORDINANCE NOS. 10285 AND 10718 (NEW SERIES), ADOPTED MARCH 22, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three (3) years of the effective date of this ordinance incorporating a portion of Parcel 9 of Parcel Map No. 8547 and Lot 150 of Villa Barbados North Unit No. 1, Map No. 7236, located south of State Route 52, west of Santo Road, in the Tierrasanta Community Plan area, in the City of San Diego, California, designated "R1-40000" on Zone Map Drawing No. B-3913, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0427 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into Community Commercial Zone, as

described and defined by Section 101.0427, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3913, filed in the office of the City Clerk as Document No. 00-17345. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance Nos. 10285 and 10718 (New Series), adopted March 22, 1972, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage.

That in the event that within three (3) years of the effective date of this ordinance incorporating a portion of Parcel 9 of Parcel Map No. 8547 and Lot 150 of Villa Barbado North Unit No. 1, Map No. 7236, located south of State Route 52, west of Santo Road, in the Tierrasanta Community Plan area, in the City of San Diego, California, designated "R1-40000" on Zone Map Drawing No. B-3913, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0427 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into Community Commercial Zone, as described and defined by Section 101.0427, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3913, filed in the office of the City Clerk as Document No. OO-17345. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance Nos. 10285 and 10718 (New Series), adopted March 22, 1972, be, and it is hereby repealed insofar as it conflicts herewith.


