
BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Pursuant to San Diego City Charter section 99, the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a fifty-five (55) year lease agreement with the San Diego Community College District of San Diego, for the lease, development, maintenance and operation of a portion of the San Diego Miramar College campus, under the terms and conditions set forth in the fifty-five (55) year Agreement on file in the office of the City Clerk as Document No. OO- 17347.


